Each member's rights and duties are listed in the club charter and bylaws. The bylaws (*huishoudelijk reglement*) are available on the v.v. Drienerlo homepage, and the charter is available from the club board. The rules below are a summary of the members' rights and duties as listed in the charter and bylaws.

- a. Payment of membership dues shall be collected by automatic deduction. Starting January 1<sup>st</sup>, 2008, an authorization is required for automatic deduction. The automatic deduction of membership dues is a contract which remains valid until further notice, and authorizes the club to automatically deduct membership dues and other unpaid debts from the member's bank account. The authorization will expire immediately should the member resign from the club. The funds will be collected two months after the amount of membership dues is set at the General Assembly. One month before the collection, the members will be notified of when the collection will take place.
- b. Each member shall be in possession of an Xtra card before November 1<sup>st</sup>. Members joining the club after November 1<sup>st</sup> shall be in possession of an Xtra card within one month. In both cases, the member shall report his or her card number to the club secretary before the deadline expires, as proof of registration.
- c. Should the undersigned fail to comply with one or more of the above conditions, the club shall be authorized to undertake any required action in the member's name. Any additional costs resulting from failure to comply with the above conditions, or the late compliance, will be the responsibility of the member.
- d. Should the undersigned wish to terminate his or her membership, he or she shall do so in writing before May 31<sup>st</sup>. If not, the membership will be automatically renewed for the next academic year.

In addition to resignation, if a member wishes to transfer his or her registration with the Dutch Football Association to another club, he or she shall notify the club secretary before May 10<sup>th</sup> of that academic year. The member shall ensure that the secretary is in possession of all of the required information on time.

- e. The board shall be notified of any changes in a member's personal information which could be relevant to the club, no later than fourteen days after the change.
  - f. Club members and/or teams responsible for any damage to the club's property or property of others, will be billed for any expenses arising from these, should the club be held financially responsible for the damage.
